Cambyses Business Continuity Plan

Cambyses Financial Advisors LLC plans to recover quickly and resume business operations after a Significant Business Disruption and respond by safeguarding our employees and property, making a financial and operational assessment, protecting the firm's books and records, and allowing our customers to transact business. In short, our company's Business Continuity Plan (BCP) is designed to permit us to resume operations as quickly as possible, given the scope and severity of the Significant Business Disruption.

The Business Continuity Plan addresses: data backup and recovery; all mission critical systems; financial and operational assessments; alternative communications with customers, employees, and regulators; alternate physical location of employees; critical supplier, contractor, bank and counter-party impact; regulatory reporting; and assuring our customers prompt access to their funds and securities if we are unable to continue our business.

Our Custodian backs up our important records in a geographically separate area. While every emergency situation poses unique problems based on external factors, such as time of day and the severity of the disruption, we have been advised by our Custodian that its objective is to restore its own operations and be able to complete existing transactions and accept new transactions and payments within a resumption time period. Your orders and requests for funds and securities could be delayed during this period.

Each product sponsor maintains all records related to your investments and account holdings and backs up important records in accordance with their business continuity plan. For more information on their contingency plan, please contact the sponsor directly at the telephone number provided on your statements.

Significant Business Disruptions: The Company's plan considers two kinds Significant Business Disruptions, internal and external.

Internal Significant Business Disruptions affect only the Company's ability to communicate and do business; e.g. Fire or loss electrical power in the office or building, or loss of key personnel.

External Significant Business Disruptions prevent the operation of the securities markets or many firms, e.g. terrorist attack, natural disaster, or other events that cause a wide-scale, regional disruption in essential services.

Internal Significant Business Disruptions: If an Internal Significant Business Disruption disrupts the Company's business operations, the Company will attempt to continue to conduct business as usual by utilizing alternative communication methods (if available), such as the Internet, or cell phones, or by moving its operations to an alternative location.

If personnel or operations must be moved to an alternate location, the Company will resume regular operations as soon as personnel can access the alternate site.

Cambyses Business Continuity Plan (Continued)

External Significant Business Disruptions: If an External Significant Business Disruption disrupts the Company's business operations, the Company will attempt to continue to conduct business as usual by moving its operations to an alternative location outside the affected area, if possible, or by providing customers with alternative communication arrangements, as indicated below, to conduct business or to access their funds and securities.

The Company will attempt to resume business and keep its customers informed regarding relevant events to the best of its ability based on the circumstances.

In all cases, the Company will resume normal business operations as soon as it can do so, based on the type and the extent of the disrupting event.

If the significant business disruption is so severe that it prevents us from remaining in business, we will assure our customer's prompt access to their funds and securities.
